General Information:	Bills are issued once a month to cover the preceding month. Bills unpaid 20 days after billing date are delinquent and shall incur a delinquent penalty of 10% the first month and 1.5% per month thereafter. Payments not received within 40 days after billing date may result in meter flow reduction or termination of service. If meter is flow restricted or service is terminated, all charges plus a meter flow restoration charge of \$100.00 or a turn on charge of \$100.00 must be paid before unrestricted meter flow will be restored or service is resumed. Customer is responsible for all delays in our receiving payment.
	After payment is received, unrestricted meter flow or resumption of service will be restored during regular working hours as soon as operationally possible, but always within three working days of payment or establishing of a repayment plan. Unrestricted meter flow or resumption of water service will not be re-established on Saturdays, Sundays or on District observed holidays.
